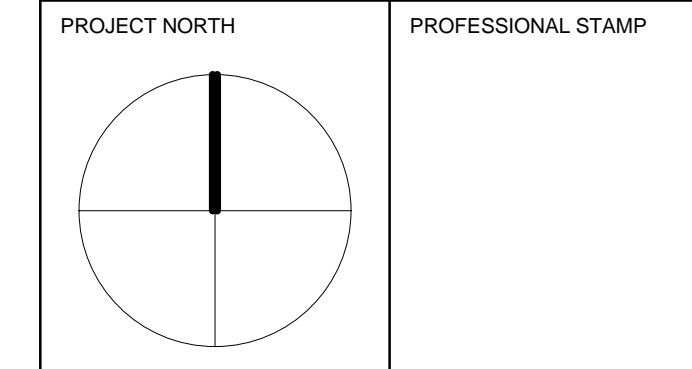

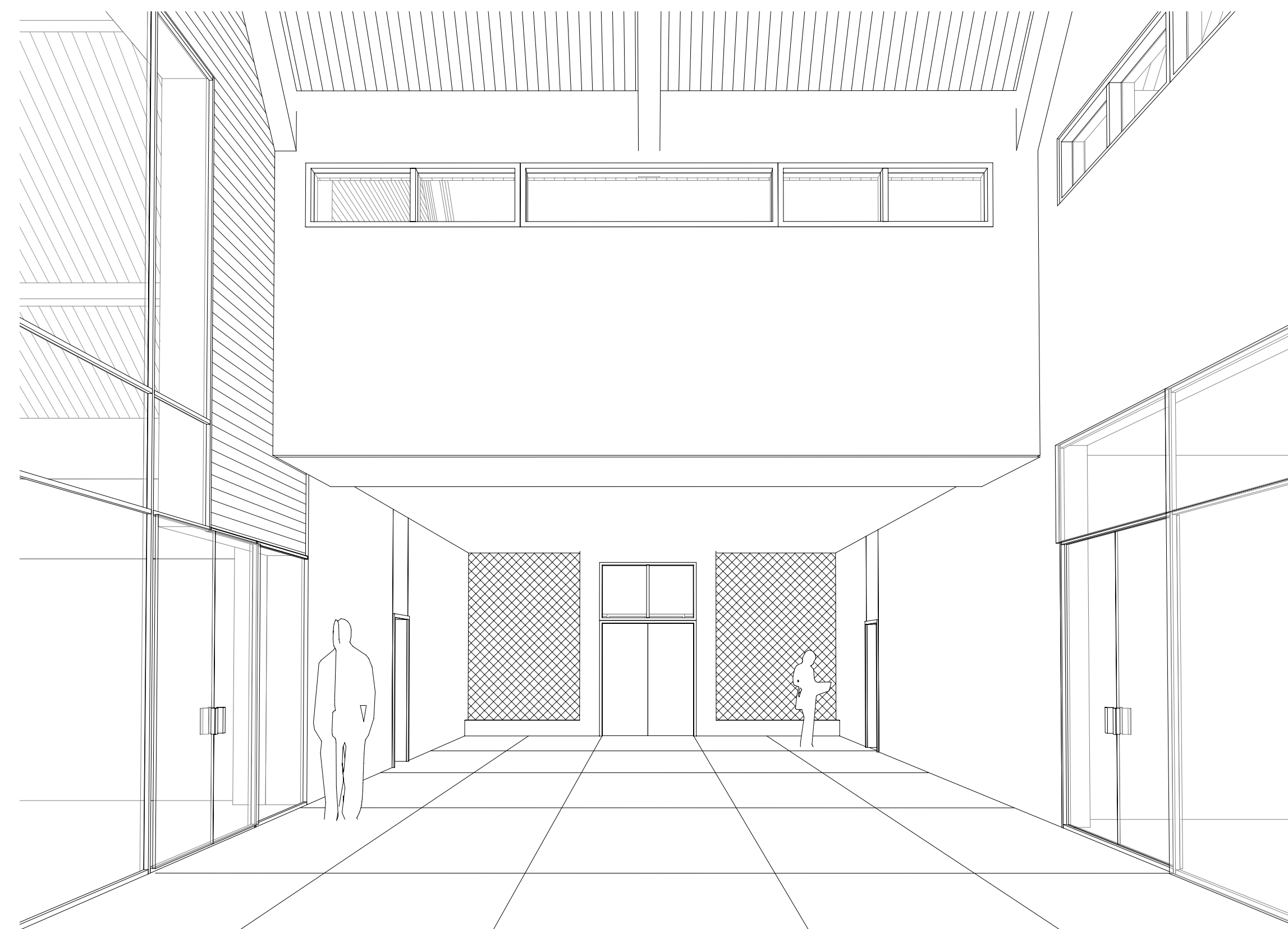

GROUND FLOOR PLAN

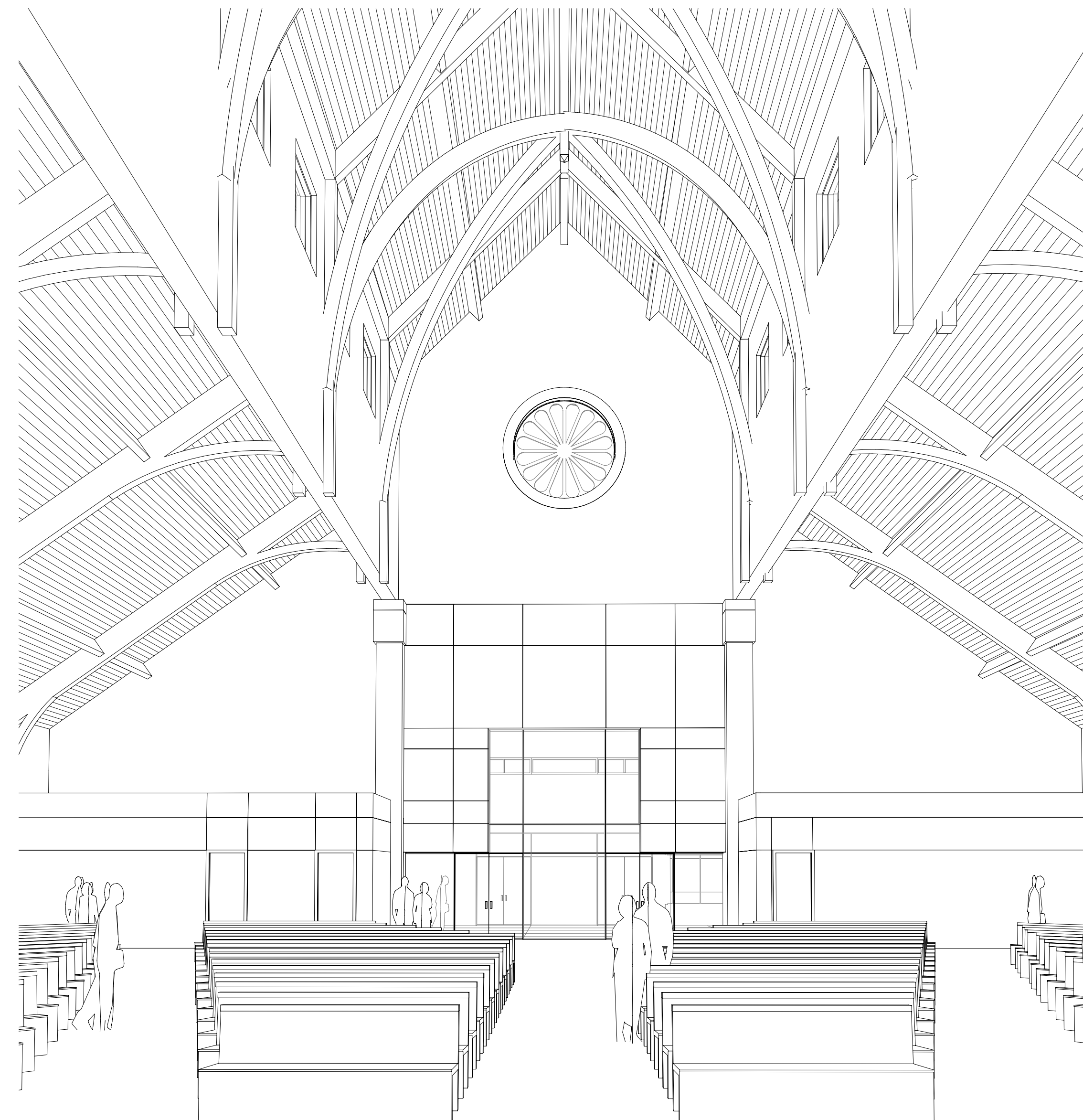




1 Narthex-Looking West To Nave
